The College has applied for fresh approval of affiliation to three year LL.B course with intake of two sections of 60 students in each section.

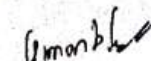

Since your University has given affiliation for the academic year 2025-2026, you are hereby requested to allow Pt. Kanhaiya Lal Mishra Vidhi Mahavidyalaya, Mau, Uttar Pradesh to admit students in imparting three year LL.B integrated degree course with intake of two sections of 60 students in each section for a period of one year i.e. for the academic year 2025-2026.

The provisional approval of affiliation shall be conditional and is subject to every Centre of Legal Education/college being required to submit a certified authenticated bank statement bearing bank stamp, date and signature, mandatorily with respect to the salary/ies being disbursed to all the teachers/faculties with effect from April, 2024. The bank statements for the upcoming months must be continued to be submitted every three months without fail, and CLE is also required to furnish list of teachers with qualifications as per BCI and UGC Rules, and further furnish proof/receipts of fulfillment of minimum library requirements, as enumerated under Schedule-III,
